Before Creating a PDF

• Add the copyright notice to the bottom of the first page of your source document. If necessary, contact **Sumesh Parameswaran** at **sumesh@mec.edu.om** for the appropriate copyright notice.

Copyright information

For papers in which all authors are employed by the US government, the copyright notice is: **U.S. Government work not protected by U.S. copyright**

For papers in which all authors are employed by a Crown government (UK, Canada, and Australia), the copyright notice is: **978-1-5386-8046-9/19/\$31.00** ©2019 Crown

For papers in which all authors are employed by the European Union, the copyright notice is: **978-1-5386-8046-9/19/\$31.00** ©**2019 European Union**

For all other papers the copyright notice is: 978-1-5386-8046-9/19/\$31.00 ©2019 IEEE

• Proofread your source document thoroughly to confirm that it will require no revision.

Creating your PDF eXpress Account

Log in to the IEEE PDF eXpress TM site (http://www.pdf-express.org/)

First-time users should do the following:

1. Select the New Users - Click Here link.

- 2. Enter the following:
- 44475X for the Conference ID
- your email address
- a password
- 3. Continue to enter information as prompted.

An Online confirmation will be displayed and an email confirmation will be sent verifying your account setup.

Previous users of PDF eXpress need to follow the above steps, but should enter the same password that was used for previous conferences. Verify that your contact information is valid.

Contacting PDF eXpress Support

Access the Publications Support Center (<u>https://supportcenter.ieee.org/app/answers/list/p/12</u>) for IEEE PDF eXpress.

If you do not find an answer in the Find Answers tab, go to the *Ask A Question* tab. Your question will be forwarded to IEEE PDF Support and answered within 3 business days.

Preparation of pdf express file

It is recommended to submit the source file (word or Latex format) in pdf eXpress and get it converted to pdf format by the pdf express. After receiving the converted copy from PDF eXpress as an email, submit it to pdf express site to check compatibility. Once you receive an email with subject "IEEE PDF eXpress: File has passed PDF Check (Paper ID XXXXXX), forward the email with attachment to Conference Operations email idconf2019@mec.edu.om with cc to suiin@mec.edu.om and sumesh@mec.edu.om. Mention the conference paper ID in the subject.

IMPORTANT: Any changes made to a PDF after IEEE PDF eXpress conversion or PDF Checking may invalidate *Xplore* compatibility. This includes headers, page numbers, copyright notice, watermarks, etc. If any of these elements are desired, they should be added to the document before a PDF is created.

Copy right

IEEE policy requires that prior to publication all authors or their employers must transfer to the IEEE in writing any copyright they hold for their individual papers. Transferring copyright is a necessary requirement for publication, except for material in the public domain or which is reprinted with permission from a previously published, copyrighted publication.

Upon transferring copyright to IEEE, authors and/or their companies have the right to post their IEEEcopyrighted material on their own servers without permission, provided that the server displays a prominent notice alerting readers to their obligations with respect to copyrighted material and that the posted work includes an IEEE copyright notice.

Authors are particularly encouraged to note the "Author Responsibilities" section of the IEEE Copyright Form, in which portions of IEEE PSPB Operations Manual, section 8.1.1.B (concerning statements in work published by IEEE are the expression of the authors) appear.

Author (one corresponding author only) will be receiving Email with links and credentials to access their eCFs (Electronic copyright form), from IEEE. Please complete the process before submitting the final camera ready pdf express compatible files. Failing to complete the eCF copyright form will lead to omission of the paper from publishing in IEEE xplore.
